Byelaws 47 to 54

47. Every Corporate Member shall have one vote unless: monies payable by him to the Institution are overdue; or he is of unsound mind and in respect if whom an order has been made by any court having jurisdiction in matters concerning mental disorder, in which case he may only vote, whether on a show of hands or on a poll, by his receiver or other person appointed by that court and any such receiver or other person may, on a poll, vote by proxy.

- 48. Non Corporate Members shall not be entitled to any vote at any general meeting.
- 49. On a poll, votes may be given either personally or by proxy.
- 50. The instrument appointing a proxy shall be in writing signed by the appointor or by his attorney duly authorised in writing. 51. The instrument appointing a proxy and the power of attorney or other authority, if any, under which it is signed or a copy (certified as true by a solicitor) of that power or authority shall be deposited at the office of the Chief Executive Officer or at such other place within the United Kingdom as is specified for that purpose in the notice convening the meeting, not less than ninety six hours before the time for holding the meeting or adjourned meeting at which the person named in the instrument proposes to vote and in default of such provisions the instrument of proxy shall not be treated as valid.
